1. Introduction (Times New Roman 11pt)

Your text starts here. Simply select/highlight this paragraph and your own text can be keyed in its place.

Extended abstracts submitted must not exceed 2 pages in length for the printed version.

All body text (that is, standard text which does not require special formatting as in lists, tables, quotes etc.) is justified left and right (often called fully justified) and the first line of the paragraph will have the first line intent by 5mm; the font used is Times New Roman 10pt.

It is, nevertheless, important to send an original docx-file and a pdf-file via e-mail.

Equations created in Word's equation editor or with MathType can be dropped in and then centered using preset tabs. The equation number is placed to the right hand side in brackets:

$$f(x) = a_0 + \sum_{n=1}^{\infty} \left(a_n \cos \frac{n\pi x}{L} + b_n \sin \frac{n\pi x}{L} \right) \quad (1)$$

$$\lim_{\delta x \rightarrow 0} \frac{\delta y}{\delta x} = \frac{dy}{dx} \quad (2)$$

There are default font sizes used in equations: Use Times New Roman 10pt for ordinary characters. Bold type is used for vectors and matrices and italic for variables. Greek letters can be typed in the font symbol, with lower case being italicized.

Tables and figures (should be framed) must be numbered sequentially and can be included in the body of the text and the caption is placed under the table; ranged in the center. If tables are placed in the text, there should be a line space after the table.

Color figures cannot be included in their original form and must be reproduced in black and white.

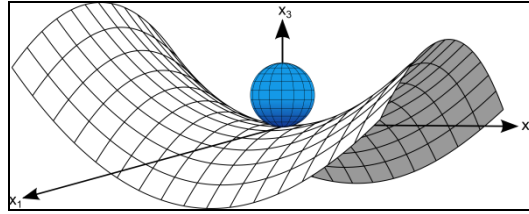


FIGURE 1: logo

In the following of symbols, a numerical list of references should be given. The format is: name of author(s) followed by a comma, followed by the title (using apostrophes) of the work, followed by the abbreviated name of the journal, then the volume number and year, and the starting and finishing page numbers of the reference. The basic font and line spacing to be used is normal in the template (Times New Roman 10pt). The journal name should be italicized for books quoted. The following fictitious examples will illustrate this format. For books and reports, titles (using italics) should be given immediately after the authors, followed by the publisher or source and number of the report followed by the date as illustrated below.

In the body of the text, references are quoted as Smith [1], Smith and Jones [2], and, for more than 2 authors, Smith et al. [3].
